The objective of the regulation is to establish rules to ensure the functioning of the internal market for electricity and includes requirements related to the development of renewable forms of energy and environmental policy, in particular specific rules for certain types of renewable power-generating facilities. Priority dispatch is the obligation on Transmission System Operators (TSOs) to schedule and dispatch energy from renewable generators, ahead of other generators as far as secure operation of the electricity system permits. Rules around Priority Dispatch are set out in EU Regulations and Directives, ensuring that dispatch of renewables is treated the same across the EU. The amended legislation will ensure that Northern Ireland in line with the Electricity Regulation and maintain effective operation of the SEM.

It is not entirely certain that the new rules regarding priority dispatch will impact on people in rural areas and, if they did, to what degree. If new electricity generating installations, after 4 July 2019, do not meet the criteria for priority dispatch, then there is a potential loss of income for electricity generators which may result in an impact on benefits, such as employment. Wind generation in particular of the size likely to be affected by this change in rules is more likely to be based in rural areas therefore it is reasonable to conclude that there may be an impact on people in rural areas. It's worth noting that a number of respondees to the consultation commented that generators should be able to opt out of Priority Dispatch. This is because it may be economically advantageous for them to decide when to generate into the market, rather than have to be available for dispatch at a time when the price is below zero.

The new priority dispatch regulations are potentially going to impact differently to people living in a rural area due to the majority of electricity generating installations being located within a rural setting. However, it is worth pointing out that any impact will apply across Northern Ireland.

The Consultation was issued on 15 July 2020, closing on 8 September 2020. One response, from Fermanagh & Omagh District Council, was received with comments relating to rural needs. The Department has included its response with its Government Response and Decision paper.

The implementation of the amended legislation should not impact on rural issues around availability of local facilities; funding programmes; transport; education; mobile services or accessing of services.

The economic impact, if there is one, is difficult to quantify. The Department considered the number of installations that the amended legislation may affect and the potential loss of income

to those installations. However, this data is not available to the Department to calculate. If a loss of income was to occur this potentially could affect rural staff employed by the generator owner but, again, the Department is not in a position to quantify this. The Department did not receive any data from stakeholders on the potential, negative or positive, social and economic impact of people in rural areas.

EU Regulations are directly applicable and therefore Member States must comply by date of operation. To ensure compliance with the Regulation there are some legislative amendments needed, as technically, due to out of date references in domestic legislation, Northern Ireland is in breach of some of the requirements in the Regulation, until legislative changes are made. One area which requires action to progress compliance is Article 12 which outlines the new rules for priority dispatch. Compliance with the new rules involves both legislative, by the Department, and practical implementation by the Single Electricity Market Committee (SEMC) and the Transmission System Operators (TSOs).

Through amending the current legislation the Department will update the provisions on rules surrounding priority dispatch to facilitate a non-discriminatory, transparent and market-based system.
